

## US Optional Platinum Commercial Limited Warranty

3M Company and 3M Authorized Window Film Dealer (collectively referred to as "Seller") agree to match the terms, conditions and limitations of your existing in force window manufacturer's seal failure warranty with like kind on the commercial windows at the location named below to the purchaser of 3M<sup>™</sup> Window Film for a period of thirty-six (36) months. In addition, 3M agrees to extend the length of the standard 3M film warranty, not including labor, by an additional twenty-four (24) months. The warranty length will NOT exceed fifteen 15 years, and is not valid for exterior applied window films. The Optional Platinum Commercial Limited Warranty, heretofore termed "Optional Warranty" does NOT include any changes to the standard glass breakage coverage.

This Optional Warranty (maximum value of \$500 per window) applies to the glass on which 3M Window Film has been applied by an authorized 3M Window Film Dealer in accordance with factory recommended installations instructions. All windows that have 3M Window Film installed must be covered. Partial warranty coverage is not allowed.

Warranty application must include the following:

- A. Standard 3M Window Film warranty application, submitted via 3M eWarranty, by the 3M Authorized Window Film dealer
- B. Proof of window film purchase. Please maintain warranty record and sales receipts
- C. Projects exceeding 50 windows must have written approval by 3M for this Optional Warranty to apply

## Note:

A valid copy of your existing window manufacturer's warranty is required to process any <u>seal failure</u> claim. Window warranty documentation must include proof of purchase at the installed address. Sample warranties will not be accepted.

This Optional Warranty does not cover misuse, abuse or acts of God. In the event that seal failure occurs on both filmed and non-filmed windows, at this individual location, Seller will assume seal failure is occurring due to window manufacturing defects, and seal failure will not be covered by this warranty. This Optional Warranty covers U.S. installations only.
